Rules & Regulations for Cruisin' through History hosted by East Contra Costa Historical Society

- 1. If accepted into the event, the exhibitor agrees to show the vehicle under the following terms and conditions. All applications are subject to ECCHS approval. Approved vehicles will have a space allotted to them at event.
- 2. A sign board may be used to list major modifications and give credit to all persons and sponsors involved in the project. No commercial tie-ins, flyers, or business cards may be passed out at event unless you are an approved Vendor of the event.
- 3. The producer of the show has the final authority to the location of all displays.
- 4. Due to safety and for liability reasons, all cars cannot be moved during the event.
- 5. ECCHS, show producer, show manager, show judges, sponsors & all show staff shall not be held responsible for theft of, or damage to, vehicles or any artifacts on display at the event.
- 6. Exhibitor agrees to obtain insurance covering exhibitor's vehicle, trailer, display and all belongings. The exhibitor assumes full responsibility for any loss/damage.
- 7. Applications must be received in our office mailbox before the entry deadline of 6/15/2025. ECCHS is not responsible for any lost or late entry materials.
- 8. Entry fees are non-refundable unless written notice is received via mail or e-mail by 6/20/2025. Cancellations forfeit entrant gift package.
- 9. Returned checks are subject to bank processing fees.
- 10. The owner, spouse and guests agree to allow ECCHS the use of their names and photos for publicity, advertising and commercial purposes before, during, and after the event without compensation to the exhibitor.
