3. ECCHS has the final authority to the location of all displays.

6. Exhibitor agrees to obtain general liability and property damage insurance. The exhibitor assumes full responsibility for any loss/damage. ECCHS assumes no liability for loss or damage.
7. Mailed applications must be received in our office mailbox before the entry deadline of 6/22/2026. ECCHS is not responsible for any lost or late entry materials.
8. Entry fees are non-refundable unless written notice is received via mail or e-mail by 6/23/2026. Cancellations forfeit entrant gift package.
9. Returned checks are subject to bank processing fees.
